



Introduction

On our Midsummer Foundation Sunday in 2023, we celebrated the life Saint Deiniol's Cathedral,

marking the end of a rich and energetic choral year, saying farewell to some of our Choristers and Choral Scholars, welcoming new additions to our collection of Gwynedd Vestments to beautify our worship, raising money for our Midsummer charity, St John Ambulance Cymru, and gathering to enjoy companionship in the Deanery garden. It was also the day on which we launched the **Pilgrim-Friends of Saint Deiniol's Cathedral in Bangor**.

The Pilgrim-Friends of Saint Deiniol's Cathedral in Bangor is a new association built on ancient, sacred ground. From its launch on our Midsummer Foundation Sunday in 2023, we hope that the Pilgrim-Friends will grow into a community of those far and wide who want to walk with us as part of the community of Saint Deiniol's Cathedral and to support and encourage our journey into the future by prayer, companionship and giving.

Yet other Pilgrim-Friends may live far away, and even overseas, sustaining a connection to our common life through our YouTube channel, Zoom meetings and editions of *Buchedd Bangor*.

Wherever you are, thank you for your care for the Cathedral and your interest in walking alongside us as our pilgrimage of faith, hope and love continues and endures.


If an error is made in the payment of your Direct Debit, by the RB or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society;

If you receive a refund you are not entitled to, you must pay it back when the RB asks you to.

You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
